## **II. Public Comment**

Marguerite Aldermen – Interested in work of Charter Commission. Agrees with intent of Commission. Movement in Vermont to ban home rule rights. Vermont is a Dillon's rule state. Has to go to the voters and then the State. Also consider other charter issues:

•CELDF – interested in charter changes around community and nature rights. Vehicle to challenge other laws. Add such rights. Aligned to the City's Strategic Vision. May help us address concerns about F-35s or PFAS contamination. Look at the CELDF website to see what other communities have done to change the charters in this way.

Sam, Eric and Jessie discussed eligibility to run for and hold municipal office as a question frequently asked. The Commission decided for the section to be an FAQ. Sam, Gerry, Alex, Eric and Liz discussed voter checklist maintenance and access, as a question frequently asked. Liz, Tori, Sam, Doug, and Prashant discussed if there should something addressing the common misconception "why doesn't somebody just become a citizen?" Alex and Liz discussed outreach to current non-citizen residents. Liz, Doug, Eric, and Hussein discussed ensuring doing no harm. Gerry, Eric, Tori, and Jessie discussed implications for school district voting.
